Annex to the visitor regulations of the Lithuanian sea museum

1. Opening hours of the museum:

1.1. The time for visiting the aquarium, expositions of the history of navigation and the ethnographic fisherman's homestead at the Lithuanian Sea Museum in May shall be changed: from 11.00 to 17.30;

1.2. Performances of dolphins and California sea lions shall not be held until a separate decision of institutions in charge.

2. Procedure of purchasing tickets:

2.1. A ticket to visit the aquarium and the exposition of the history of navigation at the Lithuanian Sea Museum shall be purchased on-line at <u>www.ljm.lt</u> and ticket office for a particular set time of entrance. The ticket shall permit entering the museum within 60 minutes past the time indicated on that ticket.

3. Conditions for visiting:

3.1. The museum may limit the flows of visitors following the regulation to allocate 10 m^2 of the visiting area of the museum per visitor;

3.2. The museum shall not attend to the visitors with symptoms of acute upper respiratory tract infections (e.g. heating, coryza, or common cold, cough, heavy breathing etc.);

3.3. Visitors must:

3.3.1. wear protective face masks or other means protecting face;

3.3.2. perform hand hygiene, comply with the etiquette of coughing and sneezing;

3.3.3. maintain safe distance, not less than 2 m, between individuals and (or) groups of individuals;

3.3.4. visit in groups not larger than 2 persons, except for family members;

3.3.5. regard precautionary signs, instructions or other guidelines as well as verbal directions given by staff of the museum related to the visiting of the museum territory.

4. Recommendations:

4.1. Persons of the risk group (individuals over 60 year and (or) ill with chronic diseases indicated in the List of Severe Chronic Diseases Which Are the Cause to Issue the Sick Leave to a Person in the Extreme Situation or Quarantine approved by the Minister of Health of the Republic of Lithuania on 23 March 2020, order No. V-483, "On Approval of the List of Severe Chronic Diseases Which Are the Cause to Issue the Sick Leave to a Person in the Extreme Situation or Quarantine": disease of the human immunodeficiency virus (HIV); cancer (if the disease has been diagnosed or there was an exacerbation and if 2 years have not passed after the end of the applied treatment); diabetes mellitus; cardiovascular diseases with chronic heart deficiency of degree 2-4; chronic diseases of the respiratory organs with respiratory insufficiency; chronic kidney diseases which are being currently treated with general or selective chemotherapy or radiotherapy and diseases in case of which 2 years have not passed after the end of; diseases which are being currently treated with immunosuppression corresponding to 10 mg/kg of methylprednisolone per day and diseases in case of which 6 months have not passed after the end of the treatment applying this

method; congenital immunodeficiency; other serious illnesses when immunosuppressive treatment applies) shall restrain from visiting;

4.2. Visitors shall purchase tickets on-line at <u>www.ljm.lt;</u>

4.3. Only one family member shall enter the ticket office and do it through the entrance door only; a buyer shall exit the ticket office through the exit door only;

4.4. Visitors shall not pay in cash;

- 4.5. Visitors shall avoid physical contact when presenting a ticket for scanning;
- 4.6. Visitors shall try not to touch the surfaces.
